Review of operations

The net profit of the Company for the year was \$ -77,786 (2008: profit of \$156,453) after deducting income tax expense of \$nil (2008:\$nil).

There were no significant changes in the Company's state of affairs during the financial year.

Discussion and analysis

Income statement

Revenue is \$322,184 (35.22 per cent) lower in the 12 month period ending on 30 June 2009 than in the previous year.

There were no significant economic or other such events effecting the operation of the company.

The main influences on the cost of operations are consultancy fees, the cost of holding events, and employee expenses.

Balance Sheet

There has been no significant change in the composition of the assets of the company.

There are non-current liabilities and current liabilities total \$55,512 as at 30 June 2009, while members' total equity was \$491,130. There is no targeted ratio given the Taskforce's non-profit status.

While total liabilities decreased by \$13,087 in comparison with the previous year, total assets decreased by \$90,873. Equity decreased by \$77,786.

Cash flow statement

Cash receipts in the course of operations were \$592,447, 34 percent lower than the previous year due to downturn in property development activities. Cash payments in the course of operations were \$685,244 - down 3.2 % from the previous years. Payments are lower in line with a more tightly focused events program, necessitated by broader economic conditions.

Payments for property, plant and equipment were financed from cash flows from operating activities.

Statement of the changes in equity

There are no separate classes of equity held by members in the company. There have been no significant changes in subscribed capital.


